+ The IRS will no longer be sending out a special package to employers for ordering bulk copies of 2008 information reporting returns such as W-2s and W-3 and 1099s and 1096, as they have always done in the past. You must order online at the IRS website. Go to http://www.irs.gov/businesses/page/0, id=23108,00.html to place your order.

It is very easy to order your information returns online. It took me about 5 minutes total. Now I just have to wait and see if my order will be processed promptly and correctly. The order confirmation said "typically orders take 7 to 15 days for delivery.
